4. Range of occupations accessible to the holder of the certificate

Road traffic technician performs the duties of a traffic officer, main traffic officer, bus/truck station entrance/exit operator, traffic safety officer, bus/truck station traffic controller, dispatcher, road patroller, passenger/goods transport capacity sales officer, taxi dispatcher and employee in passenger/truck rental offices. Employment is possible at bus stations, freight terminals, logistics companies, transport companies and companies that deal with traffic control. Self-employment is possible by setting up a logistics or transport company. During the performance of work, it is necessary to use means of personal protection and protection at work appropriate for the workplace and the work being performed as well as knowledge of providing basic first aid.
