He/she can perform tasks related to the testing, installation, maintenance and servicing of electronic circuits and devices and to prepare developmental, technological and operational documentation. Examples of professions are: a medical electronic device repairman, a photovoltaic system installer, a household appliance repairman. Self-employment is possible as a repairman, installer, etc.

The number of hours of work-based learning (practical classes/ exercises) is realised in full.

²⁾ For the learner who had previously achieved all learning outcomes of general education subjects and some learning outcomes of vocational subjects, as proven by a public document, all previously achieved learning outcomes are recognized since they form part of the qualification additionally acquired by the student, thus leading to the duration of education being proportionally shortened.
