Can also be employed in places where catalogue, TV, internet and telephone sales are performed and places where other forms of sales are carried out outside of the shop (for example, as cashier at stations, cinemas, theatres).

Can be promoted to managerial positions, such as the position of sales manager or retail or procurement manager, department head or shop manager.

The occupation of a salesperson also enables independent activity in sales business.
